SUMMARY

The M&E plan for the Strengthening Resilience of the IGAD region to the adverse Impacts of Climate Change through effective Adaptation and Mitigation Actions (RICCAMA) project has been developed with the consideration of key stakeholders and other actors in the areas of climate change adaptation and mitigation. The M&E plan includes two components addressing the target indicators in the project log frame, i.e.:

Assessing Project Performance: this component will focus on the management and supervision of project activities so as to improve efficiency and overall effectiveness of project implementation. This process will be continuous and collect information on actual implementation of project activities compared to those scheduled in the annual work plans, including the delivery of quality outputs in a timely manner, to identify problems and constraints, to make clear recommendations for corrective actions, and identify lessons learned and best practices for scaling up, etc. Monitoring of project performance will be spearheaded by Project Technical Support Unit (PTSU) through quarterly and semi-annual reports, quarterly implementation reviews, annual and technical reports and regular technical supervision field visits as required.

M&E of project impact: Evaluation of the project's success in achieving its outcomes will be monitored continuously throughout the project. The key indicators found in the logical framework (see Appendix 1), and the M&E matrix will guide the evaluation of the project results and impact. Baseline data has been collected at the start of the project activities and impact (desired change) data will be collected when appropriate during the project implementation.

Both project performance and impact M&E will contribute towards improvement in decision making and keeping the project on track towards achieving set outcomes. Project achievements will be evaluated after two years of project execution during the mid- term evaluation (Mid 2021) and at the end of the project through an independent final evaluation by ACP secretariat

1.0 INTRODUCTION

1.1 Project Background

Intergovernmental Authority on Development (IGAD) is a regional economic community of African Union while IGAD Climate Prediction and applications Centre (ICPAC) is a specialized institution of IGAD that is responsible for fostering climate services and knowledge to enhance community resilience for prosperity in the Greater Horn of Africa. The IGAD region and its economies are prone to the climate variability and change that have consistently impacted on the people living within the IGAD region who are considered to be among the most vulnerable. This is mainly due to low adaptive capacity coupled with increasing frequency and intensity of climate related risks.

IGAD/ICPAC received funding from the European Union under the 11th European Development Fund (EDF 11) to implement a three-year project titled, "Strengthening the Resilience of the IGAD region to the adverse Impacts of Climate Change through effective Adaptation and Mitigation Actions (RICCAMA)" that runs from June 2019 up to June 2022. This funding is within the framework of an existing Financing Agreement with the Secretariat of the ACP Group of States ("ACP Secretariat") for the implementation of the Intra-ACP Global Climate Change Alliance Plus (GCCA+) Programme. It contributes to the implementation of the regional component of the GCCA+ Programme.

The ACP Secretariat is the Contracting Authority and Authorising Officer for the Intra-ACP GCCA+ Programme and thus a member of the RICCAMA's Steering Committee with ICPAC's technical support unit facilitating the project's implementation.

Overall objective of the project

The overall objective of this project is to increase the resilience of the IGAD region to the adverse impacts of climate change and contribute to the achievement of the UN's Sustainable Development Goals, in particular Goal 13: *"Take urgent action to combat climate change and its impacts"* in order to reduce poverty and promote sustainable development.

Specific objectives of the project


- Enhance the capacity of IGAD, through the IGAD Climate Prediction and Applications Centre (ICPAC), to address regional and national climate change challenges and support IGAD Member States.
- 2) Support IGAD Member States to mainstream climate change adaptation and mitigation into their strategies and policies and align them to the Paris Agreement and other UNFCCC aspirations.
- Promote engagement and strategic dialogue across relevant stakeholders to manage and share information, knowledge and capacity in support of climate initiatives and actions across the region.
- 4) Strengthen the capacity of other regional and national institutions for improved service delivery within the IGAD region for addressing climate change-related challenges

2.0 OBJECTIVES OF THE PROJECT MONITORING AND EVALUATION PLAN

The main objective of the M&E plan is to provide strategic and technical guidance in the monitoring and evaluation of the RICCAMA project implementation. Specifically, the plan;

- 1. Defines all indicators, baseline values and targets that will be monitored to track project success;
- 2. Defines tools for routine data collection, analysis and reporting;
- 3. Supports decision making processes for taking corrective measures/action during the implementation of the project based on solid evidence; and
- 4. Provides a framework for the evaluation of the project as part of the accountability mechanism
- 5. Describes a system for quality assurance with emphasis on ensuring the delivery of accurate and reliable project data.
- 6. Details roles and responsibilities at the different levels of project M&E.

The M&E Plan will have four interlinked core components namely 1) Project Evaluation, 2) Results Monitoring, 3) Activity Monitoring and, 4) Learning. These components are demonstrated in Figure below.



3. 0 LINKAGE OF THE M&E PLAN WITH EXISTING M&E ARRANGEMENTS IN IGAD

3.1 Annual IGAD Operations Plan (IOP)

At the beginning of each financial year, IGAD prepares an operational plan (OP) that entails the projects and activities to be implemented as well as the budget for each activity. This OP helps the M&E Team

as well as project teams to track progress in implementation of the planned activities at IGAD level. The RICCAMA Project is already incorporated into the overall IGAD Operations Plan (IOP) 2020.

3.2 IGAD M&E Working Group

The ACP Secretariat is in charge of monitoring and reporting on the implementation of the Intra-ACP GCCA+ Programme consequently, IGAD has agreed to cooperate with ACP Secretariat, in particular on aspects related to the monitoring and reporting.

The Technical Support Unit (TSU) of the Project at ICPAC will tap into the solid technical expertise of the members of the IGAD M&E working group to support the Project. The IGAD bi-annual M&E technical meetings discusses progress in tracking Project indicators and provides support to different project teams on M&E including the identification of solutions for improving the M&E activities described in the performance indicator matrix (Table 1). The ICPAC Monitoring and Evaluation Expert will support Project Manager to link the Project work with the M&E working group of IGAD.

4.0 M&E MATRIX FOR INDICATORS, DEFINITIONS AND MEASUREMENTS

Indicators will provide parameters against which to assess project performance and achievement in terms of quantity (how many/how much?), time (when?), target and quality (how good?). Indicators will be quantitative, (number of people, number of trainings etc., semi-quantitative (scale, ranking), or qualitative (perceptions, opinions & categories). *Table 1* below provides details of the matrix.

5.0 ROUTINE DATA COLLECTION, ANALYSIS AND REPORTING

5.1 Data collection and analysis

Data will be collected on a quarterly and annual basis by the Project staff and M&E Expert using standard data collection tools from Member States focal points. Data collection will focus on capturing data on output and outcome indicators as outlined in the project logical framework (see appendix 1).

RICAMMA PSTU and M&E Expert will undertake monitoring visits to Member States to collect data and assess project implementation, document lessons learnt and make recommendations for improvement.

Quarterly Monitoring reports will be prepared and they will inform the progress of implementation of the project activities and achievement of outputs. These reports will inform the annual interim project report as well.

5.2 Reporting and learning mechanism

Reporting will be an integral part of the project and the M&E process will involve the systematic and timely collation and provision of essential information at periodic intervals. Specifically, bi-annual progress reports will be prepared and shared with both management, the Project Steering Committee and the EU not later than one month after the end of the reporting period covered by the report. The project reports will among others provide details on implementation progress (based on set outcomes, indicators and targets), challenges encountered and mitigation measures, recommendations for corrective actions in addressing key challenges and lessons learned.

Both Project interim and final reports will be prepared and submitted to the Head of Delegation of European Union in Djibouti

Furthermore, the project will stand to benefit from the on-going processes and tools being developed and implemented within the framework of the IGAD knowledge management strategy. Best practices and lessons learnt will be captured, documented and shared during implementation through existing platforms such as the GHACOF, ICPAC website and other print materials and fora.

6.0 DATA QUALITY ASSURANCE

Data quality assurance will be carried out to check the data inconsistencies including any anomaly that will have come up during data collection as a way of improving the data before its analysed.

7.0 EVALUATION FRAMEWORK

A Mid-term review and a final evaluation are planned for the project. The mid-term review will be conducted by European Union mid-way the project implementation. This will be an external review process that will assess the progress made in attaining set objectives, thus providing an opportunity to

review strategies and outputs. The ICPAC M&E Expert and the Project Technical Support Unit will be involved in the process.

At the end of the project, EU will once again carry out an external evaluation to assess the impact of the project. A before and after comparison analysis will be conducted during the final evaluation so as to examine the project's impact and draw lessons and conclusions for future similar interventions.

8.0 M&E COORDINATION AND CAPACITY BUILDING

8.1 Coordination

The Monitoring and evaluation activities of this plan will be coordinated by the M&E Expert who will work closely with the Project Manager, Project Staff and other IGAD M&E Structures.

8.2 Capacity Building

M&E Capacity building of the Project staff right from data collection, analysis and reporting will be led by the M&E Expert with technical support from the M&E Working Group members and the Project Manager.

9.0 ROLES AND RESPONSIBILITIES

9.1 ACP Secretariat

The ACP secretariat will be responsible for the overall monitoring of the project implementation as stipulated in the grant agreement and it will responsible for midterm and Final project Evaluation.

9.2 European Union Delegation in Djibouti

The European Union Delegation in Djibouti will play a critical role in supervising and guiding implementation of activities of the project. Annual work plans and Budgets will be approved by the EU delegation in Djibouti as well.

9.2 Steering Committee

The Project steering Committee will undertake the role of work plan and budget approval for the project and check all the inconsistencies that might have come and as well check if the activities are line with the Member states plans.

9.3 IGAD Executive Secretary

The Executive Secretary of IGAD as the overall accounting Officer of IGAD is responsible for the overall supervision of the project

9.4 ICPAC Director

The ICPAC Director as the overall accounting officer of the Climate Centre in Nairobi is responsible for the day to day management of the Project and approval of project funds and as well chair the Project Steering committee.
