If the deadline to request a debriefing has expired, you may still request a debriefing. In this case, we will provide the debriefing as soon as practicable, and normally no later than ten (10) Business Days from the date of publication of the Contract Award Notice.


DEADLINE: The Standstill Period is due to end at midnight on 20th May 2021 (local time).
